

DEXTER TOWNSHIP ORDINANCE NUMBER 3-A(1)

AN ORDINANCE TO AMEND THE BOATING CONTROL, BIG SILVER LAKE, WASTHENAW/LIVINGSTON COUNTIES ORDINANCE TO ADD THE DEPARTMENT OF NATURAL RESOURCES LANGUAGE REGARDING DAYLIGHT SAVING TIME AND TO CHANGE VIOLATIONS TO A CIVIL INFRACTION

THE TOWNSHIP OF DEXTER ORDAINS:

SECTION I

On the waters of Big Silver Lake, Township of Dexter, County of Washtenaw/Township of Putnam, County of Livingston, State of Michigan, no operator of any motor boat shall, during the period from 6:30 pm to 10:00 am of the following day (the hours should be 7:30 p.m. to 11:00 a.m. of the following day when Eastern Daylight Savings Time is in effect);

- A. Operate such motorboat at high speed, or
- B. Have in tow or shall otherwise assist in the propulsion of a person on water skis, water sled, surfboard, or other similar contrivance.

On the waters of Big Silver Lake, Township of Dexter, Washtenaw/Township of Putman, County of Livingston, State of Michigan, persons operating vessels shall maintain a distance of 200 feet from the shoreline and a distance of 100 feet from any raft, buoyed or occupied bathing area, or vessel moored or at anchor, except when proceeding at a 'slow-no-wake' speed and except when engaged in picking up or dropping off water skiers, so long as such operation is otherwise conducted with due regard to the safety of persons and property and in line perpendicular to the shoreline and in accordance with the laws of this State.

Any person, or other entity who violates the provisions of this ordinance shall be responsible for a civil infraction of \$100.00 for each offense.
