

# **FULTON TOWNSHIP CEMETERY REGULATIONS & CEMETERY HOURS**

- 1. The Cemeteries are open to the general public between the hours of SUNRISE to SUNSET each day.**
- 2. Visitation is encouraged, but each visitor should be aware that visitation is at your own risk. Fulton Township shall not be held liable for any type of risk or injury that occurs while visiting, planting around graves, or while attending any type of graveside service at any of our township cemeteries.**
- 3. No burial will be made until all dues and/or assessments are paid in full.**
- 4. Anyone who wishes to reserve burial space, shall contact the Fulton Township Office at 989-236-5102. Township residents are limited to four spaces per household at the township resident rate. Anything over four spaces will be the same as a non-resident space.**
- 5. Non-residents will pay a different fee than residents.**
- 6. No foundations can be constructed or any monuments or markers set until all dues and assessments are paid in full. Foundations will be constructed by the Sexton when weather allows. (No exceptions.) Foundations must be ordered from the Sexton and paid for prior to construction.**
- 7. Marker foundations shall extend a full six inches beyond the ends of the marker and will be at least six inches wider than the monument's base, which is two feet wide. Foundations shall be no larger than 2' x 14', and no smaller than 2' x 3'. Marker heights shall be restricted to 36 inches.**
- 8. All reserved unused burial spaces, must be confirmed each and every 10 years to maintain their reservation.**
- 9. For maintenance reasons, all real or artificial flowers, plants and shrubs, as well as marker posts and the like, must be placed in line with the marker foundations.**
- 10. All unsightly flowers and shrubs, will be removed from the lots without prior consent of the owner; also no glass containers for cut flowers will be allowed.**
- 11. All winter decorations will be removed by April 15, and all summer decorations by October 15 of each year.**
- 12. Any Individual planting evergreens and small trees must have permission from the Sexton or the Township Board. No large growing evergreens will be permitted, as they soon outgrow the lot and trespass on the next lot. Evergreens or shrubs growing over their lot line will be cut down by the Sexton without permission from the lot owner. All grooming of plants on the lots is the responsibility of the family members which have burial rights to that lot. Fulton Township will not be responsible if plants, trees, or shrubs die.**
- 13. No roses can be set in the ground, but may be set in a pot on the grave, so they are in line with the marker and shall be taken up in winter by the family members or friends responsible for the burial lot decorations.**
