Regular Meeting

July 12, 2021

Meeting called to order at 7:31 pm. By Supervisor Evans

Roll Call – Alberda, Evans, Morris, Modreske.

Absent – Wamhoff with prior notice.

Motion by Alberda supported by Morris to approve the agenda as presented with the addition of item D. Village Road Request to new business. All ayes, motion carried 4-0.

Motion by Modreske supported by Morris to approve the minutes for the June 14, 2021 meeting as presented. All ayes, motion carried 4-0.

Motion by Alberda supported by Modreske to approve the financial report as presented. All ayes, motion carried 4-0.

Motion by Morris, supported by Modreske to approve the bills in the amount of \$7,679.03. All ayes, motion carried 4-0.

Correspondence – Supervisor Evans discussed drain work the drain commissioner is planning. He also discussed a response to the Township Board from Aric Nesbitt. Clerk Alberda shared with the board the the Gun Lake Tribe Revenue Sharing meeting will be taking place on July 21.

ARPA Funds: A list of ARPA funds requests was discussed.

Klawiter Rezoning Request: Discussion was had on Resolution 2021-18 Amend the Hopkins Township Zoning Ordinance parcel #03-10-012-015-10 from R-1 to R-1A. Motion by Alberda and supported by Morris to approve, roll call vote: Modreske - yes, Morris - yes, Alberda - yes, Evans - yes. Motion passed 4-0.

Hopkins Township L4029- Discussion was had on the Hopkins Township L4029. Motion by Alberda and supported by Morris to levi the maximum millages allowed with the exception of the Fire Millage which will be set at 0.1000 mills. All ayes, motion passed 4-0.

Village of Hopkins Road Request: Discussion was had on a request received from the Village of Hopkins. The Village had paved a short section of 21st St. and 128th Ave. and requested a cost share of \$1,850 of which 50% would be \$925. Motion by Modreske and supported by Alberda to approve \$925 to be paid to the Village of Hopkins. All ayes, motion passed 4-0.

Board Comment – Clerk Alberda advised that the Township Resolution Book is nearly finished and advised of upcoming township office hours that will be closed.
