

# Hopkins Township Board Minutes

## Regular Meeting

### June 14, 2021

Meeting called to order at 7:33 pm. By Supervisor Evans

Roll Call – Alberda, Evans, Morris, Wamhoff, Modreske.

Absent – None.

Motion by Modreske supported by Morris to approve the agenda as presented with the addition of item 12. New Business above item a. Resolution Opposing SB46 and to change the SB number from SB46 to SB446, additionally adding item e. Wise Farm to old business. All ayes. Motion carried 5-0.

Motion by Wamhoff supported by Modreske to approve the minutes for May 10, 2021 regular meeting as presented. All ayes. Motion carried 5-0.

Motion by Alberda supported by Wamhoff to approve the financial report as presented. All ayes. Motion carried 5-0.

Motion by Morris, supported by Wamhoff to approve the bills as presented in the amount of \$33,622.56. All ayes. Motion carried 5-0.

Correspondence – There was no correspondence.

Public Comment- There was no public comment at 7:41 pm.

Reports:

County Commissioner Report – Commissioner Dugan was not present at this time; he entered the meeting at a later time and gave his report then.

Cemetery Project Update – Supervisor Evans gave an update to the Cemetery projects at Maplewood and Lakeview Cemeteries.

ARP Revenue Update – Supervisor Evans gave an update that our DUNS and SAM numbers have been entered with the State and we are waiting for more information on when/how to apply for funding.

Memorial Day Service – Evans gave an update to how well the service went, noting that the only issue was the speaker/sound system being a little quite.

Wise Farm – Supervisor Evans gave an update about the School Board’s discussions on the Wise Farm property.

Old Business:

Cyber Insurance – Discussion was had on purchasing cyber insurance for the township. Motion by Wamhoff and supported by Alberda to sign up for cyber insurance. Vote was 3 ayes, 2 nay. Motion carried 3-2.

New Business:

Resolution Opposing SB446 – Discussion was had on resolution 2021-17 Resolution Opposing SB446. Motion by Modreske supported by Morris to approve the resolution. Role Call Vote – Wamhoff -yes, Modreske – yes, Morris – yes, Morris – yes, Alberda – yes, Evans – yes. Motion carried 5-0.

DLSA Agreement – Discussion was had on an agreement with the Dorr and Leighton Sewer Authority and Hopkins Township. Motion by Modreske and supported by Alberda to allow Evans to sign and enter into the D&W agreement with costs to be funded by the DDA. Role call vote – Wamhoff -yes, Modreske -yes, Morris – yes, Alberda – yes, Evans – yes. Motion carried 5-0.

Commissioner’s Report – Commissioner Dugan gave his report from 8:16 pm to 8:43 pm.

Public Comment – Ken Blaauw gave comment from 8:43 pm to 8:45 pm.

Board Comment – Clerk Alberda stated that he was working on an ordinance book with the Township Secretary.
