### FIRST AMENDMENT TO

# INTERLOCAL AGREEMENT UNDER THE URBAN COOPERATION ACT TO ESTABLISH A NEW PUBLIC BODY CORPORATE TO PROVIDE AMBULANCE SERVICE

This First Amendment, dated 12-14, 2015, is as follows:

### **Background Recitals**

Whereas, the Townships of Dorr, Hopkins, Leighton, Martin, Monterey, Orangeville, Salem, Watson, Wayland, and the City of Wayland (hereinafter the "Original Participating Municipalities") entered into an Interlocal Agreement dated July 1, 2001, to establish the Wayland Area Emergency Medical Services to provide ambulance service, and

Whereas the Participating Municipalities desire to amend Paragraph 18 of the Interlocal Agreement to change the contribution requirements for the Participating Municipalities.

### **Amendment**

Now, therefore, in consideration of the mutual promises and covenants contained herein, the Participating Municipalities agree the paragraph 18 of the Interlocal Agreement shall be amended to read in its entirety as follows:

18. Participating Municipality Contribution. The annual contribution of each Participating Municipalities to Wayland Area Emergency Medical Services shall be determined as follows: First, each Participating Municipality shall contribute the sum of \$4,000.00. Second, one-half of the remainder of the amount needed shall be assessed to and contributed by the Participating Municipalities based on the most current federal census. Third, the remainder of the amount needed shall be assessed to and contributed by each Participating Municipality based on the average number of responses in that Participating Municipality over the past three years, not including responses to skilled nursing homes and to any Indian tribal land held in trust by the federal government. The annual contribution may be increased by vote of the Board of Directors. Provided, however, in the event of any such increase a Participating Municipality may withdraw from this Agreement by giving 60 days' written notice of withdrawal to the Board of Directors within 30 days after receiving written notice of the
