Motion by Wamhoff, supported by Modreske, to approve Ordinance No. 2008-5 which amends the zoning ordinance so as to provide standards requiring adherence to the particular zoning district in which property is located in the circumstance of boundary line adjustment and to repeal all ordinances or parts of ordinances in conflict herewith as approved by the Township and County Planning Commissions. Motion by Arndt, supported by Evans, to approve the recommended amendments to the 2008/2009 general fund budget. All ayes.

Motion by Arndt, supported by Evans, to authorize the Treasurer, to draw \$40,991.60 from the Fire Millage account payable to Dorr Township for our donated portion of the new rescue truck and also to move the remaining cash balance to a principal payment on the fire loan. All ayes.
