



# NORVELL TOWNSHIP CLEAN-UP PROGRAM

At the June 3, 2023 board meeting, the Norvell Township Board voted to renew the Clean-Up Program that provides the Property Owners of Norvell Township two (2) free Transfer Station Tickets for each parcel of property they own. This will allow the Property Owner to take their trash to Lakeshore Recycling Systems (LRS), formerly Modern Waste Systems in Napoleon MI.

**\*\*\*Ticket expiration date – June 30<sup>th</sup> of the current Fiscal Year\*\*\***

- You will need to pick up the tickets at the Norvell Township Office during the regular business hours.  
Monday, Wednesday 8:00am – 4:00pm  
Friday 8:00am – 12:00pm
- Proof of property ownership is required to receive the tickets.  
Driver's License, or Property Tax Statement(s)

CLOSED SATURDAY

IT IS ILLEGAL TO TRANSPORT AN UNSECURED LOAD. YOUR LOAD MUST BE COVERED PRIOR TO TRANSPORTING IT TO LAKESHORE RECYCLING SYSTEMS AND YOU COULD BE TICKETED FOR NOT DOING SO.

You **must** have a Transfer Ticket with you, or you will be charged for the load and expected to pay at the time of dumping at the site.

The ticket must have your signature and address on it.

You will have to scale your load **both** full and empty.

Each ticket is good for one-time use only and is limited to 1,000 pounds.

**You must have your Transfer Ticket with you, or you will be charged for the load and expected to pay at the time of dumping at the site.**

Tickets expire on June 30<sup>th</sup> of the Fiscal Year.

Each ticket is good for **one-time use only** and is **limited to 1,000 pounds**.

*IT IS ILLEGAL TO TRANSPORT AN UNSECURED LOAD. YOUR LOAD MUST BE COVERED PRIOR TO TRANSPORTING IT TO LAKESHORE RECYCLING SYSTEMS. YOU COULD BE TICKETED FOR NOT DOING SO.*

### **ACCEPTABLE ITEMS** - Subject to change at LRS discretion

- ✓ Bagged municipal solid waste (household garbage)
- ✓ Larger items such as: furniture, mattresses, box springs, toys, bicycles, appliances\*, home fixtures, and any other items if they are considered non-hazardous and can be safely lifted by two people.
- ✓ Latex Paints – paint must be dried-up in the container (use sawdust, kitty litter or just leave the lid off until the paint dries and is solid).
- ✓ Large plastic drums or metal burn barrels – **NO HOT ASH** allowed in barrel.
- ✓ Concrete
- ✓ Metal
- ✓ Yard waste - MUST be bagged.
- ✓ Construction materials

### **UNACCEPTABLE ITEMS** - Subject to change at LRS discretion

- X Liquid waste
- X Hazardous waste
- X Non-latex paints & varnishes
- X Motor oil & solvents
- X Batteries
- X Regulated medical waste
- X Appliances that contain Freon such as Refrigerators & air conditioners, etc.
- X Any additional items that are listed by the Michigan DEQ as banned from Michigan Landfills
- X Tires

\* Appliances MUST have the Freon removed and tagged by a licensed facility before it will be accepted
