## PUBLIC COMMENT PROTOCOL

Members of the public have an opportunity, under the agenda item Public Comment, to address the Board for **no more than three (3) minutes** on any item that is not on the agenda. We ask that speakers provide their name.

Members of the public may also address a specific agenda item at the time that item is taken up by the Board for **no more than three (3) minutes** if recognized by the chair. We ask that speakers provide their name.

Should three or more speakers wish to voice a similar opinion, then an option for a longer presentation may be more appropriate for the group. The **group** may choose a spokesperson who can address the Board on that specific topic for **up to ten (10) minutes**.

Civility and mutual respect will prevail at all times.

*Public comment is an opportunity for the Board to gather information and hear the concerns of the people; it is not intended for a dialog between the Board and the members of the public.*
